Key Ideas and Details

- RL.1.1. Ask and answer questions about key details in a text.
RL.1.2. Retell stories, including key details, and demonstrate understanding of their central message or lesson.

Print Concepts

Text Types and Purposes

Speaking and Listening

Comprehension and Collaboration

- SL.1.1. Participate in collaborative conversations with diverse partners about grade 1 topics and texts with peers and adults in small and larger groups.
Follow agreed-upon rules for discussions (e.g., listening to others with care, speaking one at a time about the topics and texts under discussion).
Build on others' talk in conversations by responding to the comments of others through multiple exchanges.
Ask questions to clear up any confusion about the topics and texts under discussion.
SL.1.2. Ask and answer questions about key details in a text read aloud or information presented orally or through other media.
SL.1.3. Ask and answer questions about what a speaker says in order to gather additional information or clarify something that is not understood.

Language

Conventions of Standard English

- L.1.1. Demonstrate command of the conventions of standard English grammar and usage when writing or speaking.
Print all upper- and lowercase letters.
Use common, proper, and possessive nouns.
Use singular and plural nouns with matching verbs in basic sentences (e.g., He hops; We hop).
Use personal, possessive, and indefinite pronouns (e.g., I, me, my; they, them, their, anyone, everything).
Use verbs to convey a sense of past, present, and future (e.g., Yesterday I walked home; Today I walk home; Tomorrow I will walk home).



- \_\_\_ Use frequently occurring adjectives.
- \_\_\_ Use frequently occurring conjunctions (*and, but, or, so, because*).
- \_\_\_ Use determiners (e.g., articles, demonstratives).
- \_\_\_ Use frequently occurring prepositions (*during, beyond, toward*).
- \_\_\_ Produce and expand complete simple and compound declarative, interrogative, imperative, exclamatory sentences to prompts
- \_\_\_ **L.1.2.** Demonstrate command of the conventions of standard English capitalization, punctuation, and spelling when writing.
  - \_\_\_ Capitalize dates and names of people.
  - \_\_\_ Use end punctuation for sentences.
  - \_\_\_ Use commas in dates and to separate single words in a series.
  - \_\_\_ Use conventional spelling for words with common spelling patterns and for frequently occurring irregular words.
  - \_\_\_ Spell untaught words phonetically, drawing on phonemic awareness and spelling conventions.

**Vocabulary Acquisition and Use**

- \_\_\_ **L.1.4.** Determine or clarify the meaning of unknown and multiple-meaning words and phrases based on *grade 1 reading and content*, choosing flexibly from an array of strategies.
  - \_\_\_ Use sentence-level context as a clue to meaning of word / phrase.
  - \_\_\_ Use frequently occurring affixes as a clue to the meaning of a word.
  - \_\_\_ Identify frequently occurring root words (e.g., *look*) and their inflectional forms (e.g., *looks, looked, looking*).
- \_\_\_ **L.1.5.** With guidance and support from adults, demonstrate understanding of figurative language, word relationships and nuances in word meanings.
  - \_\_\_ Sort words into categories (e.g., colors, clothing) to gain a sense of the concepts the categories represent.
  - \_\_\_ Define words by category and by one or more key attributes (e.g., a *duck* is a bird that swims; a *tiger* is a large cat with stripes).
  - \_\_\_ Identify real-life connections between words and their use (e.g., note places at home that are *cozy*).
  - \_\_\_ Distinguish shades of meaning among verbs differing in manner (e.g., *look, peek, glance, stare, glare, scowl*) and adjectives differing in intensity (e.g., *large, gigantic*) by defining or choosing them or by acting out the meanings.
- \_\_\_ **L.1.6.** Use words and phrases acquired through conversations, reading and being read to, and responding to texts, including using frequently occurring conjunctions to signal simple relationships (e.g., *because*).

**Mathematics**

**Operations and Algebraic Thinking**

**Represent and solve problems involving addition and subtraction.**

- \_\_\_ **1.OA.1.** Use addition and subtraction within 20 to solve word problems involving situations of adding to, taking from, putting together, taking apart, and comparing, with unknowns in all positions,
- \_\_\_ **1.OA.2.** Solve word problems that call for addition of three whole numbers whose sum is less than or equal to 20, by using objects, drawings, and equations with a symbol for the unknown number

**Understand and apply properties of operations and the relationship between addition and subtraction.**

- \_\_\_ **1.OA.3.** Apply properties of operations as strategies to add and subtract.<sup>2</sup> *Examples: If  $8 + 3 = 11$  is known, then  $3 + 8 = 11$  is also known. (Commutative property of addition.) To add  $2 + 6 + 4$ , the second two numbers can be added to make a ten, so  $2 + 6 + 4 = 2 + 10 = 12$ . (Associative property of addition.)*
- \_\_\_ **1.OA.4.** Understand subtraction as an unknown-addend problem. *For example, subtract  $10 - 8$  by finding the number that makes 10 when added to 8. Add and subtract within 20.*

**Add and subtract within 20.**

- \_\_\_ **1.OA.5.** Relate counting to addition and subtraction (e.g., by counting on 2 to add 2).
- \_\_\_ **1.OA.6.** Add and subtract within 20, demonstrating fluency for addition and subtraction within 10. Use strategies such as counting on; making ten (e.g.,  $8 + 6 = 8 + 2 + 4 = 10 + 4 = 14$ ); decomposing a number leading to a ten (e.g.,  $13 - 4 = 13 - 3 - 1 = 10 - 1 = 9$ ); using the relationship between addition and subtraction (e.g., knowing that  $8 + 4 = 12$ , one knows  $12 - 8 = 4$ ); and creating equivalent but easier or known sums (e.g., adding  $6 + 7$  by creating the known equivalent  $6 + 6 + 1 = 12 + 1 = 13$ ).

**Work with addition and subtraction equations.**

- \_\_\_ **1.OA.7.** Understand the meaning of the equal sign, and determine if equations involving addition and subtraction are true or false. For ex: which equations are true?  $6 = 6$ ,  $7 = 8 - 1$ ,  $5 + 2 = 2 + 5$ ,  $4 + 1 = 5 + 2$ .
- \_\_\_ **1.OA.8.** Determine the unknown whole number in an addition or subtraction equation relating three whole numbers. *For example, determine the unknown number that makes the equation true in each of the equations  $8 + ? = 11$ ,  $5 = \_ - 3$ ,  $6 + 6 = \_$ .*

**Number and Operations in Base Ten**

**Extend the counting sequence.**

- \_\_\_ **1.NBT.1.** Count to 120, starting at any number less than 120. In this range, read and write numerals and represent a number of objects with a written numeral.

**Understand place value.**

- \_\_\_ **1.NBT.2.** Understand that the two digits of a two-digit number represent amounts of tens and ones. Understand the special cases:
  - \_\_\_ 10 can be thought of as a bundle of ten ones — called a “ten.”
  - \_\_\_ The numbers from 11 to 19 are composed of a ten and one, two, three, four, five, six, seven, eight, or nine ones.
  - \_\_\_ The numbers 10, 20, 30, 40, 50, 60, 70, 80, 90 refer to one, two, three, four, five, six, seven, eight, or nine tens (and 0 ones).
- \_\_\_ **1.NBT.3.** Compare two two-digit numbers based on meanings of the tens and ones digits, recording the results of comparisons with the symbols  $>$ ,  $=$ , and  $<$ .

**Use place value understanding and properties of operations to add and subtract.**

- \_\_\_ **1.NBT.4.** Add within 100, including adding a two-digit number and a one-digit number, and adding a two-digit number and a multiple of 10, using concrete models or drawings and strategies based on place value, properties of operations, and/or the relationship between addition and subtraction; relate the strategy to a written method and explain the reasoning used.
- \_\_\_ **1.NBT.5.** Given a two-digit number, mentally find 10 more or 10 less than the number, without having to count; explain the reasoning used.
- \_\_\_ **1.NBT.6.** Subtract multiples of 10 in the range 10-90 from multiples of 10 in the range 10-90 (positive or zero differences), using concrete models or drawings and strategies based on place value, properties of operations, and/or the relationship between addition and subtraction; relate the strategy to a written method and explain the reasoning used.

**Measurement and Data**

**Measure lengths indirectly and by iterating length units.**

- \_\_\_ **1.MD.1.** Order three objects by length; compare the lengths of two objects indirectly by using a third object.
- \_\_\_ **1.MD.2.** Express the length of an object as a whole number of length units, by laying multiple copies of a shorter object (the length unit) end to end; understand that the length measurement of an object is the number of same-size length units that span it with no gaps or overlaps. *Limit to contexts where the object being measured is spanned by a whole number of length units with no gaps or overlaps.*

**Tell and write time.**

- \_\_\_ **1.MD.3.** Tell and write time in hours and half-hours using analog and digital clocks.

**Represent and interpret data.**

- \_\_\_ **1.MD.4.** Organize, represent, and interpret data with up to three categories; ask and answer questions about the total number of data points, how many in each category, and how many more or less are in one category than in another.

**Geometry**

**Reason with shapes and their attributes.**

- \_\_\_ **1.G.1.** Distinguish between defining attributes (e.g., triangles are closed and three-sided) versus non-defining attributes (e.g., color, orientation, overall size); build and draw shapes to possess attributes.
- \_\_\_ **1.G.2.** Compose two-dimensional shapes (rectangles, squares, trapezoids, triangles, half-circles, and quarter-circles) or three-dimensional shapes (cubes, right rectangular prisms, right circular cones, and right circular cylinders) to create a composite shape, and compose new shapes from the composite shape.<sup>1</sup>
- \_\_\_ **1.G.3.** Partition circles and rectangles into two and four equal shares, describe the shares using the words *halves, fourths, and quarters*, and use the phrases *half of, fourth of, and quarter of*. Describe the whole as two of, or four of the shares. Understand for these examples that decomposing into more equal shares creates smaller shares.
